MIRANDA WARNING-ADVISEMENT OF RIGHTS

1. YOU HAVE THE RIGHT TO REMAIN SILENT.
2. ANYTHING YOU SAY CAN BE USED AGAINST YOU IN A COURT OF LAW.
3. YOU HAVE THE RIGHT AT THIS TIME TO TALK TO A LAWYER AND HAVE HIM PRESENT WITH YOU WHILE YOU ARE BEING QUESTIONED.
4. IF YOU CANNOT AFFORD TO HIRE A LAWYER, ONE WILL BE APPOINTED TO REPRESENT YOU BEFORE ANY QUESTIONING, IF YOU WISH.
5. YOU CAN DECIDE AT ANY TIME TO EXERCISE THESE RIGHTS AND NOT ANSWER ANY QUESTION OR MAKE ANY STATEMENTS.

WAIVER

1. DO YOU UNDERSTAND EACH OF THESE RIGHTS I HAVE EXPLAINED TO YOU?
2. HAVING THESE RIGHTS IN MIND, DO YOU WISH TO TALK TO US NOW?

IN ADDITION TO MIRANDA WARNINGS, WASHINGTON STATE LAW REQUIRES THAT THE FOLLOWING ADVISEMENT BE GIVEN TO EVERY PERSON TAKEN INTO CUSTODY:

YOU HAVE THE RIGHT TO COUNSEL. IF YOU ARE UNABLE TO PAY FOR COUNSEL, YOU ARE ENTITLED TO HAVE ONE PROVIDED WITHOUT CHARGE.

ADDITIONAL WARNING TO JUVENILE

IF YOU ARE UNDER THE AGE OF 18, ANYTHING YOU SAY CAN BE USED AGAINST YOU IN A JUVENILE COURT PROSECUTION FOR A JUVENILE OFFENSE AND CAN ALSO BE USED AGAINST YOU IN AN ADULT COURT CRIMINAL PROSECUTION IF YOU ARE TO BE TRIED AS AN ADULT.
